- AE executed the Pilot ESS contract with its energy storage integrator, Doosan GridTech Services, LLC (Doosan) in October 2016. Project plans and design work associated with Task 1 are underway.
- AE submitted its Task 2 Deliverable Report to the TCEQ on schedule. Task 2 included AE's selection of a vendor for construction and operation of the solar PV facility associated with this solar plus storage project. The report describes AE's completion of the task including an overview of the adjacent solar PV facility's construction and integration with the grid and a Gantt chart or timeline illustrating major project milestones.
- PowerFin Partners (PowerFin) continues to work with the City of Austin Development Services Division (DSD) to obtain approval of its solar PV facility site plan application. This permitting process is required prior to construction.
