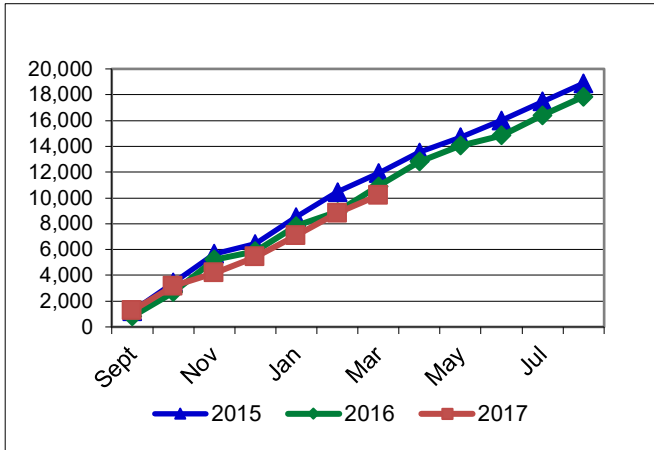
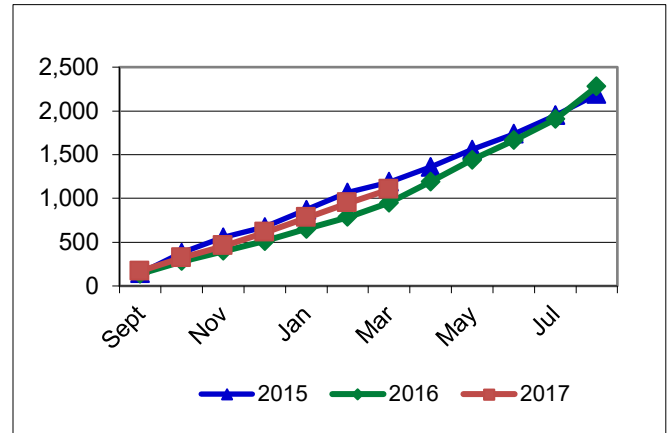

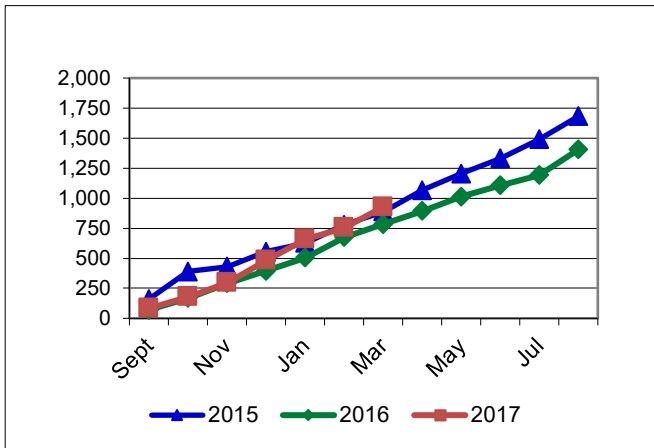
**Figure 1: Number of Notices of Violation**



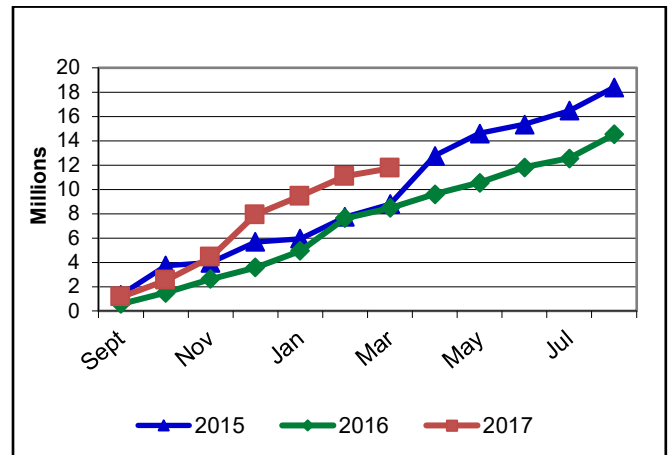
**Figure 2: Number of Enforcement Action Referrals**



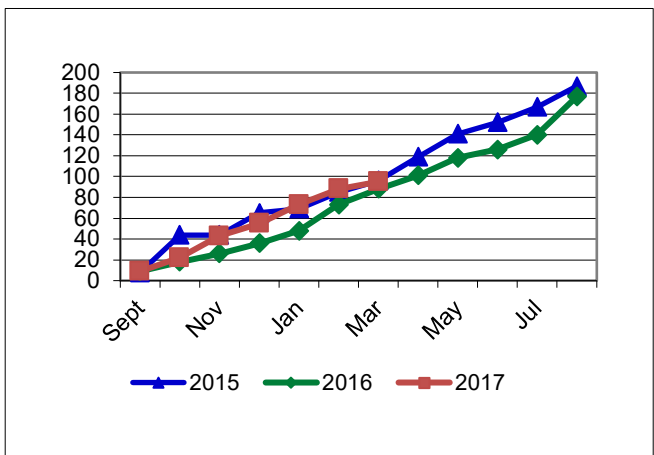
**Figure 3: Number of Effective Orders**



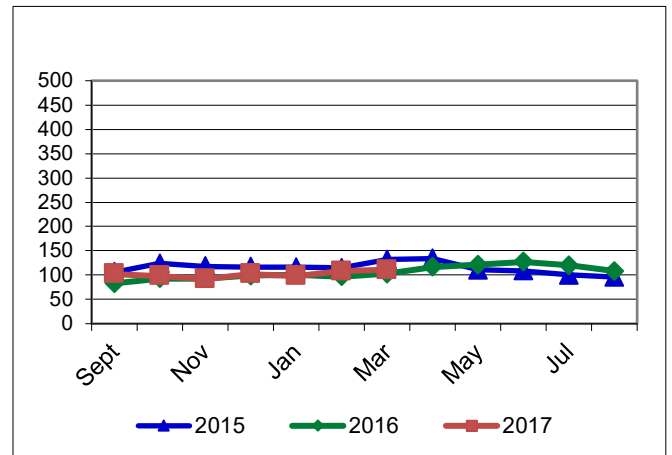
**Figure 4: Assessed Penalties**

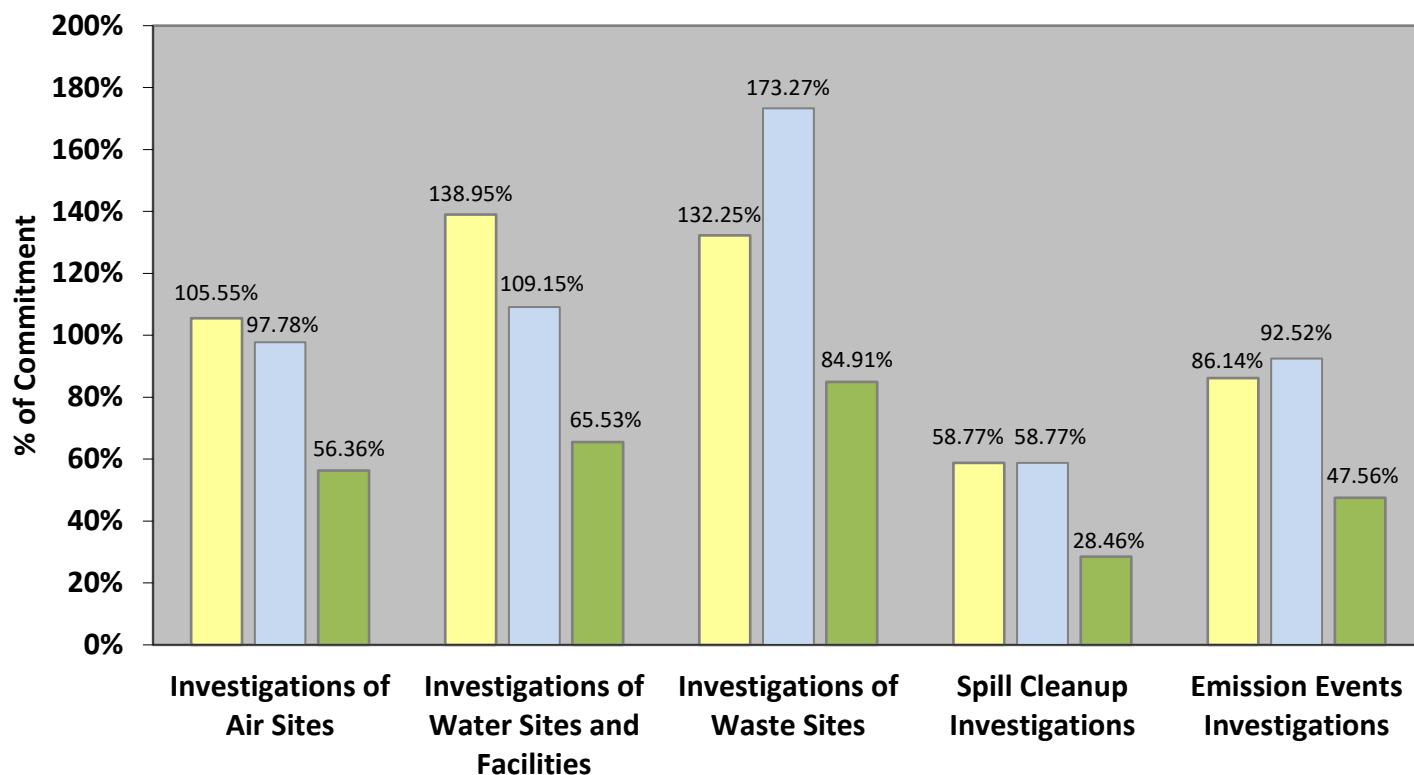
